Tickets are issued by the Atherton Tableland Agricultural Society (ATAS) ABN 65 861 621 504.

The Ticket is sold on the condition that the holder is bound by the terms and conditions. By purchasing the Ticket, you agree to be bound by the terms and conditions as well as any other conditions specified by ATAS on its website [www.athertonshow.com.au](http://www.athertonshow.com.au)

### General

A reference to "ATAS" in these Terms and Conditions is the Atherton Tableland Agricultural Society ABN 65 861 621 504 trading as the Atherton Show Society.

By purchasing a Show Ticket through ATAS or its authorised agents you are acknowledging and agreeing to be bound by these Terms and Conditions, the General Terms and Conditions for Ticket Sales and Entry as well as any other conditions specified by the ATAS on its website.

The ticket is issued for use at the 2025 Atherton Show - Monday 30<sup>th</sup> June and Tuesday 1st July 2025.

A ticket allows entry for that ticket type only. Details of ticket types can be found on the Atherton Show Website or from an Authorised Agent.

ATAS is not liable to give a refund or exchange the ticket for any reason. A refund or exchange may be provided if the event is cancelled to ticket holders who are able to provide their undamaged tickets.

The 2025 Show will be operated in accordance with applicable Queensland Health directions in place at the time of the event, which are subject to change. Customers must comply with these requirements in place at the time of the event.

The operation of some attractions may be affected by adverse weather conditions or maintenance activity.

ATAS reserves the right to add, withdraw or substitute artists, displays, exhibitions and attractions and/or vary advertised program and prices.

ATAS reserves the right to prohibit the use of cameras, audio, and video recorders.

ATAS reserves the right to inspect all bags and containers being brought into the Showgrounds and refuse entry to any person carrying any item that in ATAS absolute discretion is considered dangerous or prohibited.

ATAS reserves the right to refuse entry to any person whose ticket is damaged, has been defaced in any way or was not obtained through a seller authorised by ATAS.

ATAS (or authorised agent) reserves the right to require the presentation of valid and current ID such as an Australian driver's licence, Australian passport, or proof of a Concession Card (Aged, Disability or Veteran). Carer entry is available when a valid ticket is held by a person with a companion card. This entry is free of charge when accompanying the companion card holder for the period of the show they are in attendance. (1 carer per person). No wrist band for re-entry will be issued.

Pass outs may only be used for re-entry to the Show Showgrounds on the day of issue. Only one (1) Pass out is allowed for each Ticket holder. Suitable ID as outlined in Show Showground T&C's may be required.

ATAS is not liable to give a refund or exchange the Bonus Dollars for cancellation of any reason.

Bonus Dollars can be used in conjunction with cash at the discretion of each ride operator.

The ATAS and ride operators reserve the right to refuse acceptance of any Bonus Dollars that have been damaged or defaced in any way or were not purchased through an ATAS authorised seller.

Ride operators reserve the right to refuse entry to a ride where the operator deems the participation by that person to be dangerous or in breach of ride restrictions.
